



# O Ministries Inc. Privacy Policy

**Effective Date: 8/15/2025**

O Ministries Inc. ("O Ministries Inc.," "we," "us," or "our") is a non-profit Christian outreach ministry. We value your trust and are committed to protecting your privacy. This Privacy Policy explains how we collect, use, share, and safeguard your information when you visit <https://www.oministriesinc.org> (the "Site"), interact with our programs, donate, subscribe to communications, or otherwise engage with us.

By using the Site or providing information to us, you agree to the terms of this Privacy Policy. If you do not agree, please discontinue use of the Site.

## 1) Information We Collect

We collect information to serve you, support our ministry operations, and improve your experience.

- Information you provide directly:
  - Contact details: name, email address, phone number, mailing address.
  - Account details: username and password (if account features are offered).
  - Donation information: amount, frequency, and method of donation. Our payment processor processes payment card data; we do not store full card numbers.
  - Communications: prayer requests, inquiries, messages, and responses to surveys or forms.
  - Event/Program registrations: attendance details, preferences, and related notes.
  - Volunteer applications: experience, availability, and background information (as applicable).
- Information collected automatically:
  - Device and usage data: IP address, browser type, operating system, pages viewed, time spent, referring URLs, and general location data (based on IP).
  - Cookies and similar technologies: for functionality, analytics, and preferences. See "Cookies & Similar Technologies" below.
- Information from third parties:
  - Donation platforms, email service providers, analytics tools, or social platforms may share limited data consistent with their privacy practices and your settings.

We do not knowingly collect personal information from children under 13. If you believe a child under 13 has provided information, contact us so we can delete it.

## 2) How We Use Your Information

We use your information to support our mission and deliver a reliable, helpful experience. For example:

- To operate and maintain the Site, including troubleshooting and analytics.
- To respond to inquiries, prayer requests, and support needs.
- To manage donations, send donation receipts, and maintain records as required by law.
- To communicate ministry updates, newsletters, event invitations, and opportunities to serve or support.
- To personalize content and improve usability.
- To administer programs, training, and events (including confirmations and reminders).
- To ensure security, prevent fraud, and protect our rights and those of our community.
- To comply with legal, tax, and regulatory obligations.

Where required by law, we rely on consent, legitimate interests in advancing our outreach mission, performance of a contract (e.g., fulfilling a registration), and compliance with legal obligations.

### **3) How We Share Information**

We do not sell your personal information. We may share information in limited circumstances:

- Service providers and vendors: With trusted third parties who assist with website hosting, analytics, email delivery, payment processing, event registration, and data storage, bound by confidentiality and data protection obligations.
- Legal and safety: When required by law, subpoena, or legal process; to respond to lawful requests by public authorities; or to protect our rights, property, safety, or that of others.
- Organizational transfers: In the unlikely event of a restructuring, merger, or transfer of operations to another non-profit entity, information may be transferred as part of that process, subject to this Policy or a comparable policy.
- With your consent: When you explicitly direct us to share information or opt in to a specific disclosure.

### **4) Data Security**

We use administrative, technical, and physical safeguards to protect your information against loss, misuse, and unauthorized access. Examples include encryption in transit (HTTPS), access controls, and vendor due diligence. No method of transmission or storage is completely secure; we encourage you to use strong passwords and keep your account details confidential.

### **5) Data Retention**

We retain personal information only as long as necessary to fulfill the purposes described in this Policy, including legal, accounting, and reporting requirements. Donation and tax-related records may be retained for the period required by applicable law.

### **6) Cookies & Similar Technologies**

We use cookies and similar technologies to:

- Enable core Site functions (e.g., page navigation, secure areas).
- Remember preferences (e.g., language or form data).
- Analyze Site traffic and performance to improve usability.
- Support limited marketing or outreach measurement.

You can control cookies through your browser settings. Disabling certain cookies may impact Site functionality. We may also use third-party analytics (e.g., Google Analytics) to understand usage trends. These providers may set their own cookies; consult their policies for details and opt-out options.

## **7) Third-Party Links and Services**

Our Site may link to third-party websites, apps, or services (e.g., donation platforms, event tools, social media). We are not responsible for the privacy practices of those third parties. Review their privacy policies before providing personal information.

## **8) Your Rights and Choices**

Depending on your location and applicable law, you may have the right to:

- Access, correct, or update your personal information.
- Request deletion of your personal information, subject to legal obligations.
- Object to or restrict certain processing.
- Withdraw consent where processing is based on consent.
- Opt out of marketing communications at any time by using the unsubscribe link in emails or contacting us.

We will respond to verified requests within the time required by law. We may need to verify your identity before completing a request.

## **9) International Users**

If you access the Site from outside the United States, your information may be processed and stored in the U.S. and other countries with different data protection laws than your own. We take steps to protect your information consistent with this Policy and applicable laws.

## **10) Do Not Track**

Some browsers offer “Do Not Track” (DNT) signals. Because there is no uniform industry standard for DNT, our Site does not currently respond to these signals. We continue to monitor developments in this area.

## **11) Changes to This Policy**

We may update this Privacy Policy from time to time. The “Effective Date” indicates the latest revision. Material changes will be posted on the Site, and we encourage you to review the Policy periodically.
